| Any amount, 4th or subsequent offense | 1 year in prison | 10 years in prison, and a \$5k fine |
| Theft by Taking or Receiving, \$1500 or more | 1 year probation | 10 years in prison and a \$5k fine |

Trafficking cocaine or meth

|-------------------------------------------|-------------------------------------------|--------------------|
| 28-199 grams | 10 years in prison and a \$200k fine | 30 years in prison |
| 200-399 grams | 10 years in prison and a \$300k fine | 30 years in prison |
| 400+ grams | 25 years in prison and a \$1,000,000 fine | 30 years in prison |
| 1 st Degree Vehicular Homicide | 3 years probation | 15 years in prison |
